

## **BYLAW NO. 35**

### **A BYLAW OF THE MUNICIPAL DISTRICT OF CLEAR HILLS NO. 21, IN THE PROVINCE OF ALBERTA, FOR THE PURPOSE OF PROVIDING FOR THE NAMING OR NUMBERING OF ROADS, STREET AND AVENUES AND FOR ASSIGNING OF HOUSE NUMBERS.**

WHEREAS, under provisions of Section 58 of the Municipal Government Act, being Chapter M-26.1 of the Revised Statutes of Alberta, 1994, and amendments thereto the Council may provide for the naming and numbering of roads or areas within its boundaries and may assign a number or other means of identification to buildings or parcels of land; and

WHEREAS, the Council of the Municipal District of Clear Hills No. 21 are desirous of naming or numbering roads, streets, avenues and houses in the Hamlet of Worsley.

NOW THEREFORE, the Council of the Municipal District of Clear Hills No. 21, in the Province of Alberta, duly assembled, hereby enacts as follows:

1. THAT, the streets and avenues within the Hamlet of Worsley shall be named or numbered as shown on the attached Schedule "A".
2. THAT, the lots and parcels of land within the Hamlet of Worsley shall be numbered as shown on the attached Schedule "A".
3. THAT, it shall be the duty of every property owner, at his own expense, to have property numbers shown on or near front entrances, within three months from receipt of the final house numbering system from the Municipal District of Clear Hills No. 21. Said numbers shall be prominently displayed, shall be at least three (3) inches in height and painted in a contrasting color that can easily be read from the street or avenue.
4. THAT, the Municipal District of Clear Hills No. 21 shall as soon as practical erect at each intersection, a post or posts showing street and avenue numbers or names, or where feasible to display such street or avenue numbers on corner buildings or telephone or power poles conveniently located.
5. THAT, any person or persons violating the provisions of this bylaw or not complying with the requirements as set out herein, or any person destroying, tampering with, or changing any number of sign posts placed to comply with this bylaw shall be subject to the provisions of Section 549 and 533(1)(c) of the Municipal Government Act, Statutes of Alberta, 1994 and amendments thereto.
6. THAT, this bylaw shall come into force and effect upon the date of final reading hereof.

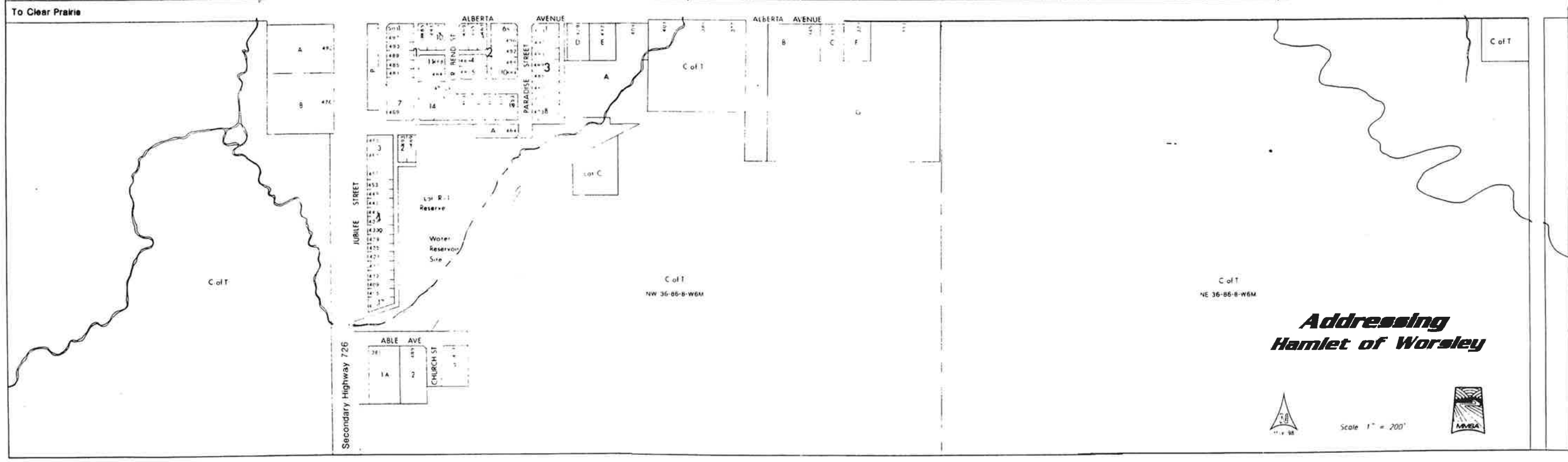
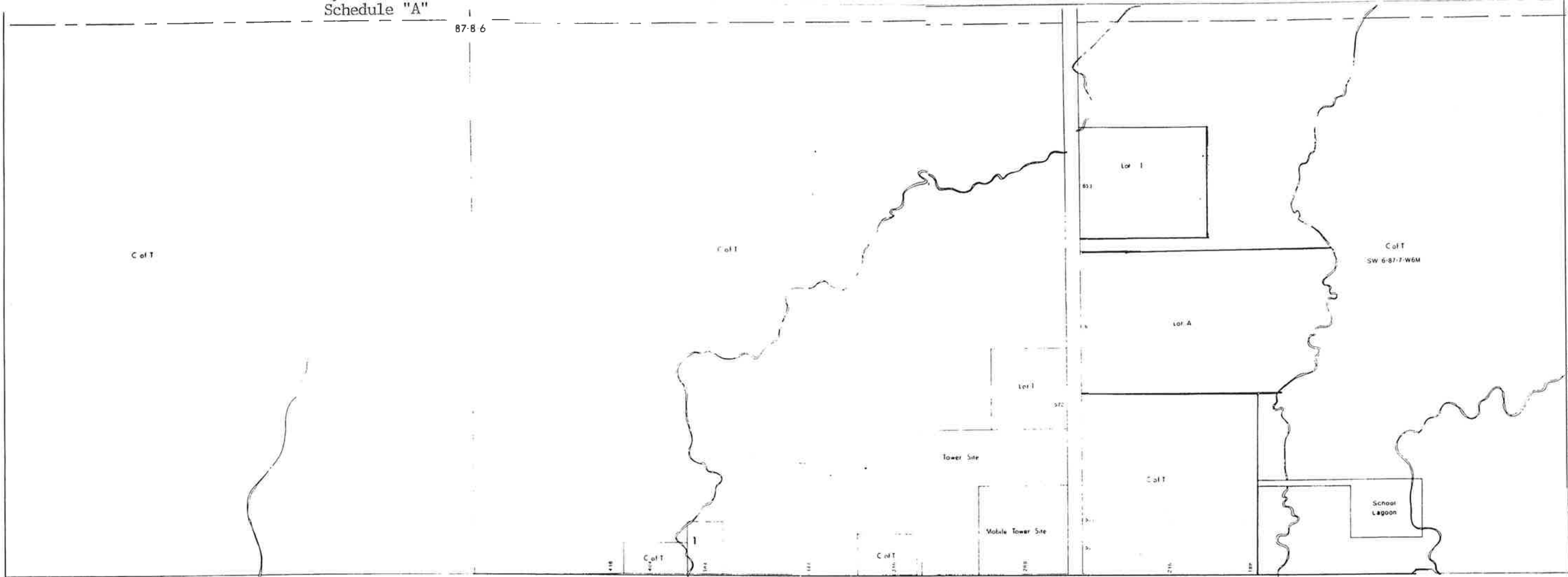
