Title: **SIGNAGE OF RECREATIONAL & COMMUNITY FACILITIES and HISTORICAL LANDMARKS**

## **1. Policy Statement**

- 1.1. Clear Hills County will support the local tourism industry by ensuring visitors are provided with essential local roads based directional and way-finding information to enhance the quality of their travel experience within the County.
- 1.2. This Signage of Recreational & Community Facilities and Historical Landmarks Policy is intended to compliment the Tourism Highway Signage Program - Sign Up Alberta that provides signage on provincial highways by providing the opportunity for local tourism industries to have directional and information signage within the local road network.
- 1.3. For consistency in treatment, these sites will be signed the same way. The program is supported by two broad signage categories:
  - 1.3.1. Tourism oriented directional signage
  - 1.3.2. Logo Signs – signage for service businesses such as food, gas and lodging
- 1.4. Clear Hills County shall annually, in the interim and final budget, allocate a portion of the annual signage budget for recreational and community facility signage within the County.

## **2. Responsibilities**

- 2.1. Those local tourism industry providers, community facilities or individuals and clubs seeking to have directional or way finding information for their site installed within the local road network will submit a signage application by April 30<sup>th</sup>, each year.
- 2.2. The County will review the applications received, and pending acceptance and capacity of the annual budget allocated for this program will have the signage installed as part of the regular annual sign program.
- 2.3. The County will be responsible for providing, installing and maintaining signs approved within this policy.
- 2.4. Tourism sites and community facilities must have been active in the previous year, to qualify for signage.
- 2.5. Historical Landmark signage will be installed for:
  - “One room” School houses
  - Inactive cemeteries
  - Original settlers homestead sites
  - Original settlers businesses, such as sawmills, garages, etc.

- Original community sites
