1. Approximately 66 km of highway pavement
2. Equivalent to 1.75 km within the Hamlet of Cleardale.
3. Equivalent to 1 km within Hamlet of Worsley.
4. Hines Creek Access
5. Cross walk at County Office staff entrance

Location Descriptions:

- From Worsley Range Road 80 West on Clear Prairie Road to Range Road 104
- Hines Creek north access, Range Road 45, from Highway 685 to Highway 64
- From Worsley East of Range Road 80 to Range Road 70 continuing south to Township Road 862 to Range Road 54.
- Range Road 80 West of Township Road 870 to Water Plant

Requesting price per kilometer of pavement line painting for the listed locations as well as lump sum price for the cross walk.

Paint Specification: Alberta Transportation TPC Specification for White and Yellow Traffic Paint.

Start Date: Contractor must give Clear Hills County notification one week prior to commencement.

Completion Date: Line Painting must be completed by September 1, 2025.

Bidders will be required to provide:

1. Proof of valid insurance
2. Alberta WCB clearance included in the sealed quote.
3. References

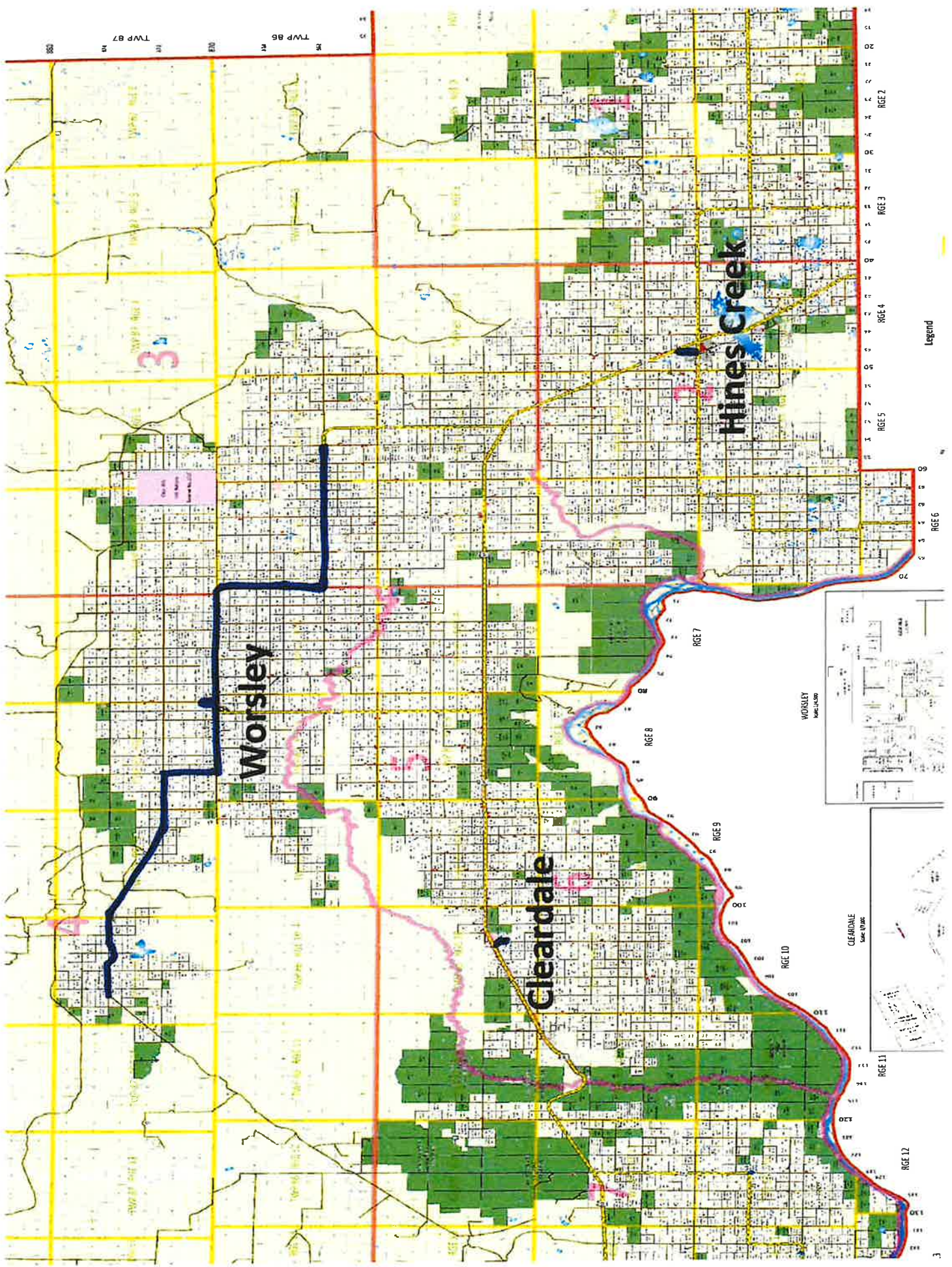
